The reading and adoption of the following proposed Ordinance by the Board of County Commissioners of Santa Rosa County, is scheduled for 9:30 a.m., August 23, 2007, in the Commissioners meeting room at the Administrative Center, 6495 Caroline Street, Milton, Florida.

AN ORDINANCE ESTABLISHING A DIRECT CONTROL AREA FOR THE AREA DESCRIBED AS WESTPORT DRIVE, REQUIRING ANY ANIMAL IN THE DESIGNATED AREA WHICH IS OFF THE PROPERTY OF ITS OWNER OR PERSON RESPONSIBLE FOR SAID ANIMAL TO BE UNDER DIRECT CONTROL OF SAID OWNER OR PERSON RESPONSIBLE FOR SAID ANIMAL; PROVIDING FOR CODIFICATION; AND, PROVIDING FOR AN EFFECTIVE DATE.
